



POLICY FOR USE OF TENNIS COURTS

1. The Tennis Courts are for the sole recreational use of all Raven's Run Property owners (members) and their guests. Lessons may be taught by any instructor chosen by the Homeowner for the family. No one may give lessons to non-residents on our courts.
 - a.) Members, their immediate family, and overnight houseguests may utilize the tennis courts at their pleasure. Members with overnight houseguests (three or more days) who wish to utilize the court should notify the Management Company and give the names and the period of time they will be visiting.
 - b.) Members must accompany and be present at all times for all non-resident guests not included in paragraph 1.a.)
2. Hours of Tennis Court usage are from 7:00 a.m. until 10:00 p.m. Play must be completed by 10 p.m. If you are playing tennis in the evening under the lights, please be sure to turn the lights off.
3. The Raven's Run Board of Directors shall have complete authority to canvass the area and enforce all rules and regulations.
4. Players and their guests must wear tennis shoes and appropriate attire. All members and guests must wear shirts.
5. No reservations are required. However, if you are utilizing the court and other players are waiting, a "one hour limit for singles" and a "one and one-half hour limit for doubles" shall be honored.
6. Only playing participants are permitted on the courts. Players and spectators shall not walk across or behind a court while a point is being played.
7. No bikes, skates, rollerblades, skateboards or other non-tennis activities are allowed.
8. No food is allowed on the courts.
9. No smoking on the courts.
10. All trash shall be placed in the containers located on the courts.
